Greetings! As we together face the second year of the COVID-19 pandemic, Sacred Heart College of Lucena City, Inc., as an educational institution that strives for quality education, continues to provide access to online learning services as recommended by the Department of Education (DepEd) for Integrated Basic Education (IBED) and Senior High School (SHS) students.
